#### B. Stakeholder Engagement

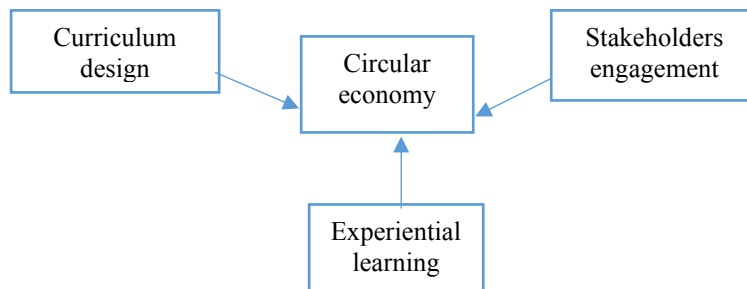
